Sub- Submission of proposal for direct recruitment of Accountant-cum-Data Entry Operator.

Sir,

I am directed to invite a reference to this Department Notification No. 4727, dtd. 27.02.2024 on the above cited subject and to say that as per Odisha Accountant-cum-Data Entry Operator (Method of Recruitment and Conditions of Service) Rules, 2024, 70% of sanctioned posts of Accountant-cum-Data Entry Operator shall be filled up by direct recruitment through independent Body i.e. Odisha Sub-Ordinate Staff Selection Commission (OSSSC). As per Rule- 6 of the said Rules, the Appointing Authority i.e. concerned Collector shall submit proposal to the Panchayati Raj and Drinking Water Department for filling up of the vacancies of the posts, as may be decided, taking into consideration various aspects of cadre strength and the proposal submitted shall be examined at Government level and PR&DW Department shall submit the requisition to the Commission for filling up of the vacant posts in the districts.


Earlier, all Collectors were requested to furnish vacancy position of ADEO for initiation of process of direct recruitment of ADEO vide this Department Letter No. 16358, dtd. 24.06.2024. But in the meantime, 153 eligible GRS (who could not be absorbed as ADEO due to lack of posts under UR/ SEBC category in their concerned districts) have been absorbed as ADEO in the nearest district, where "UR" vacancy of ADEO is available by formulating a policy vide this Department Resolution No. 11607, dtd. 02.05.2025.

Further, it has come to notice of this Department that many GRS, who were not found eligible in terms of ADEO Rules, 2024 by the District Administrations in the meeting of District Selection Board, filed Writ Petitions before the Hon'ble High Court with a prayer for their absorption, which are under sub-judice and many instances have been found, where Hon'ble High Court have directed the Opposite Parties to consider the case of the

Petitioners for absorption.

Hence, you are requested to furnish proposal to this Department in the prescribed vacancy position format () along with the list of such GRS cases, if any, as mentioned above in separate sheet for filing up of the vacancies in the post of Accountant-cum-DEO by way of Direct Recruitment **within 15 days** for onward submission of requisition to OSSSC.
